TO THE APPLICANT: PLEASE READ THESE INSTRUCTIONS BEFORE FILING APPLICATION AS A GUEST STUDENT.

1. You must meet the following requirements to qualify for admission as a guest student:
 - A. You must be in attendance at an accredited law school and be eligible to return.
 - B. You must have earned a minimum cumulative "C" grade point average (2.0) and not be on academic probation.
